I, Lancelot Armstrong, # 693504 do hereby swear that the following statement is true and correct and made of my own free will, from my own personal knowledge:

Over the past twenty years I have raised numerous official bias within our cases; which resulted in blocking our equal access to the courts; knowing that their actions were contrary to constitutional laws and also violated said promised covenant policy governed by law.

Many problems were known to the attorneys, who were mostly fearful of the police officers.

The state attorneys bias schemes created an increase backlash, that produced illegal retaliation interfering with my pending cases.

It is a different system, within said system at times, corruption especially fraudulent billing by officials that used State and Federal funds to illegally interfere with my constitutional legal rights.

The ignorance to constitutional duty and proper ^{law} procedure are a dual role in balancing the rights of every human being and to decide to prosecute officials that ^{violated} laws in my cases. The reality that sufficient evidence to protect my life and to presecute bias people, that continue to illegally interfere with my pending cases with their creative lies and created material witnesses at times.

There is a different level of justice, in which the goal was contrary to saving human lives. Society believed the officials lying schemes, that created sad

circumstances for people they do not like. Yet! Most people do not have the nerve to speak out against what is wrong at times.

So, where do we go from here? ... Why are officials multiple human cruelty allowed to get worse?

It is senseless to believe, that bias officials always prosecute the right person. Public opinion still matters, to force some meaningful balance within the court rooms.

This is the reason why I respectfully request your assistance as my counsel on record to obtain copies of my jail and prison logs of each person, who gain entry to visit me on a official level. And those who were blocked legal entry to visit me.

I, also, need the area on record that reflect the complaints and rquests, that were filed throughout the years; and the court orders that forced compliance as well; and the civil litigation issues; and the criminal pro-se, stating whether or not there was interference to equal access to the courts, in order to read^{back} addressing grievances of great importance. Because, of those violators immunity it might further circumvent administrative remedies and proper relief from the courts.

The fact is that I have to get actual exhibit evidence to state a proper cause of action.

The violators knowingly bias scheme to circumvent their own administrative policy, to further retaliate by ignored legal requests, grievances, resulted block my rights to properly exhaust the grievance procedure, which interferred with my legal access to go to the next level for meaningful remedy.
