has destroyed my life and the lives of my family. Not only for myself, but most importantly for my dear children who had their father and provider stolen away from them because of this unconscionable situation.

Bias Law enforcement. Knowingly Broken Laws, resulted, prejudiced my pending cases. This insidious ordeal began for my family and I, February 16, 1990, and the burden has only gotten worse for us. The state court appointed Attorneys to represent my case then severely limited their services to my cases. At the prison where I am housed, said state's system Administrative Schemes has restricted my legal access to the institutional Law Library, illegal Block Telephone rights, illegally interference with the mail process. many times illegally Block essential legal materials, such as pens, legal papers, envelopes, etc. There have been instance where I have been denied the ability to make important Telephone calls to aid in my cases. About my case: The person who committed this crime admitted to it and received 75 years in prison. but because a "police officer" lost his life during the commission of Wayne Coleman crime, the government was determined that someone had to pay for this loss with their own life.

Therefore prosecutor Michael J. Satz, used his official elected power to impel false testimony to further this ignoble reprisal. Notwithstanding, the existence of an eye witness and other evidence that would have conclusively shown my innocence was ~~repressed~~ repressed. State Attorney Michael J. Satz was
